for 2045 and actively contribute to the strategies outlined in the "Delivering a Net Zero NHS" report.

## **Current Emissions Reporting**

The baseline year of 2024 remains the most recent and complete data set. DKM Healthcare will adopt an annual review cycle to update and reflect emission trends and reductions.

## **Emissions Reduction Targets**

Our targets remain ambitious yet achievable:

- Net Zero Scope 1–3 emissions by 2040
- Support the NHS Carbon Footprint Plus goal by 2045

In February 2025, Liva Healthcare acquired Discover Momenta and Momenta Newcastle, both of which operate with minimal physical infrastructure, aligning well with our carbon-conscious approach.

## **Completed & Ongoing Carbon Reduction Projects**

#### 1. Supplier Engagement

- Switched to soy-based nutrition products (NUPO) to lower carbon footprint.
- Use of recycled packaging and optimised logistics routes.
- Cloud infrastructure powered by Google Cloud and AWS, both leaders in green cloud operations.

#### 2. Employee Engagement

- o Ongoing ESG training for staff.
- o Policies promoting virtual meetings and remote-first service delivery.

#### 3. ISO 14001 Alignment

 Planning accreditation for Environmental Management System standards.

#### 4. Annual Performance Review

 Improved data capture, especially for remote workers and Scope 3 categories.

#### 5. Natural Gas Replacement

o Feasibility testing for Air Source Heat Pumps to replace gas usage.

#### 6. Green Energy Sourcing

o Procuring REGO-certified electricity to ensure renewable sources.

### 7. Supply Chain Emissions

o Engage suppliers in emissions data sharing and reduction strategies.

#### 8. Business Travel Policy

- Enforce a "Remote by Default" principle.
- Detailed tracking of travel modes and energy usage.

#### 9. Green Procurement

- Vet suppliers based on environmental credentials.
- Mandatory ESG training for all new suppliers and staff.

#### 10. Staff Wellbeing Initiatives

o Cycle-to-work and carpooling incentives.

- o Laptop donation and recycling schemes.
- o Electronic document sharing to reduce waste.
